

# PAREVARTAN SCHOOL - Admission Policy

Parevartan School, within its resources, makes every possible effort to meet the individual needs on their path to spiritual, academic, physical and social development.

This development ensues in educational opportunities that are both curricular and co-curricular. As a result, the admission policies and procedures are such that individuals seeking admission to Parevartan School are able to demonstrate their potential for success in the curricular and co-curricular opportunities.

## **General Policies**

Parevartan School does not discriminate on the basis of race, caste, creed, religion or physical disability, in the administration of its educational policies, admission policies, curricular and co-curricular programs. A student seeking admission is required to appear for Entrance Examination / Counselling and interview conducted by the school. Admission will be taken subject to the student meeting the requirement of admission rules and regulations laid down by the school. The number of admissions in each class will be proportionate to the vacant seats available in the institution on the date of result declaration.

## **Prerequisites for Admission:**

### **Nursery and K.G.**

Admission to Nursery is allowed for children of age group 3-4 years. Admission to KG will be permitted only for children of age group 4-5 years. The Admission process for both these classes includes a Mandatory Personal Interaction with the Principal/Vice-Principal/Coordinator to assess the physical and mental abilities of the child.

### **Classes from I to Class VIII**

For these Classes, Entrance Examination is conducted in accordance with the Vacant Seats available in the Institution. The Examination will be taken for the following subjects:

- Classes I to Class-VIII : English, Science/EVS & Mathematics

Candidate's Performance in the Entrance Examination will be the sole criteria for selection. Students who are successful in the Entrance Examination will be called with their Parents for a counseling session with the Principal/Vice Principal/Coordinator of the school.

## **Age Criteria**

Age Criteria for admission to the school is based as per the CBSE norms.

- Minimum age for Admission to Nursery is 3 Years & above, as on, 31st March of the year of admission. Maximum age of Admission to Nursery is 4½ Years.
- Minimum age for Admission to K.G. is 4 Years & above, as on, 31st March 2015. Maximum age of Admission to Nursery is 5½ Years.
- No relaxation in age will be given under any circumstances.

### **Documents Required**

- Birth Certificate (issued by State Municipal Corporation) copy to be submitted.
- School leaving certificate/Transfer Certificate signed by Head of Institution last attended.
- Photographs of the child
- Photographs of the parent
- Address Proof /Aadhar Card of the parent or the ward

*Please note that if the proper documents are not submitted with the hard copy, the form will be summarily rejected, for which the entire responsibility lies with the parents'/guardians'. Form can also be rejected if any information provided by them is found incorrect and not in accordance with the documentary evidence.*
